# A PROMISE IS A PROMISE.

During 2013-14, our Community Foundation grew to encompass a total of 140 endowed funds. That translates into a lot of generous people who chose to work with the Community Foundation to carry out their charitable aspirations. And on our end, that's a lot of promises made.

Understanding that "because we said so" isn't the most effective form of promise keeping, each of our endowments is held in place by a fund agreement; a legal contract that stipulates how the funds will be managed, invested and distributed.

Unfortunately, sometimes the spirit of who we are and how we operate gets lost in the legal jargon. So please allow me to share five promises that are the foundation of our Foundation.

**A promise to be ethical** – it's about how we treat people, the policies by which we operate, and how our actions reflect our integrity in all we do. This encompasses policy making, development work, investing finances, directing grants, awarding scholarships, book-keeping -- even how we respond to phone calls and e-mails.

While we don't claim perfection, we aim for it.

**A promise to honor donor intent** – we understand that through endowments we are charged with being caretakers of legacies. Every person motivated to give – whether it's a gift to a charity or a bequest made to create an endowment – deserves to have their wishes honored now and in the years to come.

**A promise to be good stewards** – our capacity for charitable grant making comes as a result of thoughtful, prudent investing.

A portion of annual returns are distributed as grants while at the same time we maintain – and even grow – our base of assets to carry us into the future.

**A promise to identify community needs** – community foundations have the unique capacity to respond to changing needs. We acquire understanding of these issues by acting as a catalyst and convener, gathering data and actively seeking input from community stakeholders. This information is used to create a framework for decision making that helps

us determine the best use of foundation resources.

**A promise to be transparent** – we believe there is no better way to gain public trust than being open in regard to our governance, policies and procedures. We invite you to browse our financial and organizational documents that support our culture of transparency as well as our National Standards designation. Our tax id number is 351860518.

The work highlighted throughout this report was carried out in reflection of these five promises.

You might be wondering who the "we" is when it comes to commitments made on behalf of the Community Foundation. A four-person professional staff, a well-respected board of directors and over fifty volunteer committee members from throughout Whitley County are the promise keepers for our organization.

I'll close by offering sincere gratitude to the philanthropic individuals to whom these promises have been made – our donors. Every time you read about a grant that lifted up a non-profit

organization or hear about a Foundation supported program that made a difference to someone in our community, we hope you will take pride in knowing that your generosity to the Community Foundation helped to make these good things possible.



# OF HOPE

Imagine this scenario. You are a single mom with two young children ages 4 and 2. The younger child, a son, is disabled and requires special care. You have a high school diploma and work at a pizza place. What's a mother to do?

She mothers. And she works. And she decides to go to college.

For Amber Sroufe, back in 2009, the decision to continue her education was easy; it held the promise of a better future for her and her children. The hard part was in the details. It meant carving out time to take classes and study while holding down a part-time job and keeping up a household. At times it meant finding and paying for childcare. There was gas to be purchased for trips to Fort Wayne three times a week and more than a few college text books with hefty price tags. Thankfully, there was also Horizons of Hope.

The program began in 2006 when a pair of anonymous donors approached the Foundation with an idea. Their hearts were telling them to find a way to help ease some of the burden for single parents who were trying to juggle

childcare, work and school. They turned to the Foundation for assistance and together we created Horizons of Hope.

Overseen by a committee who reviews applications which are submitted by referral from social service organizations, the fund offers hard-working, single parents a little help in the form of gas money, childcare support, book fees or tuition costs.

It wasn't until a few years down the road, when Amber had almost completed her degree that she realized the assistance she had received had not come from a state grant or an agency, but from two very generous, caring people who simply wanted to help her without knowing who she was. “I just couldn't believe that someone would do something like that,” she recalls. “It made a world of difference for me and my kids and I'll always be grateful for their generosity and support.”

Amber earned her Associates degree in Nursing from St. Francis University and plans to continue her education.



# THE WHITLEY PROMISE



By the year 2020, over 60% of jobs in the U.S. will require post-secondary education in the form of a two- or four-year degree or credential. For all families, and especially those with first-generation college-bound students, it's time to shift the mentality that the end goal of education is a high school diploma. In our community, local leaders embraced the idea of a three-pronged approach to prepare students for their future. It's called the Whitley Promise and here's how it unfolded:

**Step 1:** Encourage parents to establish college savings accounts. Our friends at Parkview Health took the lead by offering to put an initial gift of \$25 into every new 529 College savings plan for kids in kindergarten and first grade – all parents needed to do was sign up!

**Step 2:** Get the kids pumped up about their future careers and education. Elementary grades K-1 at Whitko Community Schools and grade 1 at Smith-Green and Whitley County Consolidated, all visited Manchester University (at the same time!) to experience a college campus. They took part in hands-on, interactive stations and participated in a walk around the mall, which symbolized taking their first steps toward their future dreams. *Walk into my Future* was followed by classroom activities designed to reinforce the idea that education is the key to their career success.

**Step 3:** Show them we care! Students were encouraged to look for friends and family members who would support their educational dreams. When the students each raised the second \$25 for their 529 College Savings Account, community champions stepped up and matched the donation 3:1!

Understanding that the ambitious Whitley Promise required a true partnership between schools, families, local businesses and non-profit organizations, the Community Foundation proactively offered a \$10,000 challenge from unrestricted endowment dollars to kick-start the community match. Sixteen funders supported the initiative by providing the funding necessary to offer students a 3:1 match for their college savings accounts.
